## Waiver of Liability Claims:

Competitors compete in the event at their own risk. They bear the sole responsibility according to civil and criminal law for any damage caused by them or the vehicle used by them where no exclusion of liability is agreed on. If the driver is not personally the owner and holder of the vehicle used by him, he shall release the persons named in the following from any claims by the vehicle owner and holder as well.

Participants, competitors, drivers, vehicle owners/holders and assistants declare that they waive all claims of any kind arising in connection with the event, the competition, special tests for achieving maximum speeds or the shortest driving times, or the connected test drives against

- FIA, FIM/UEM, DMSB and its member organisations, the Deutsche Motor Sport Wirtschaftsdienst GmbH, its president, organs, managers, general secretaries,
  - The AVD, DMV, their sub-organisations,
  - The organiser, his agents, the referees, the race track owners,
  - Agencies, race services and any other persons connected to the organisation of the event,
  - Servants and auxiliary persons of any persons and offices named above,
- except in case of damage from injury to life, body or health due to wilful or negligent violation of obligations – also by a legal representative or servant of the group of persons relieved from liability;
- against

- The other participants (participants, competitors, co-drivers), their assistants, the owners, holders of the other vehicles,
- Their own competitor or driver (any agreements between the competitors and drivers shall take precedence) and their own assistance,

you waive all claims of any kind arising in connection with the event, the competition, special tests for achieving maximum speeds or the shortest driving times or the connected test drives, except in case of damage from injury to life, body or health due to wilful or negligent violation of obligations - also by a legal representative or servant of the group of persons relieved from liability - and except for any other damage due to wilful or negligent violation of obligations - also by a legal representative or servant of the group of persons relieved from liability.

The waiver of liability shall enter into effect for all parties involved with submission of the entry. The waiver of liability shall apply for claims for any legal reason, in particular regarding damages claims from contractual and non-contractual liability and for claims from tort. Any implied exclusions of liability shall not be affected by the preceding exclusion of liability.

Concerning any injury occurring or being determined in the course of the event or in the case of any damage to health that are suitable for putting in question fitness for the automotive sport permanently or temporarily, the signatory releases all attending physicians – regarding the safety risk possibly also arising for third parties in this respect – from doctor-patient confidentiality towards the officials working in responsible offices at the event (race physician, race director, sports officials).

For those of you that don't return this form completed in time a space of 2.5 metres width in total will be allocated.
